PART 4. FARMS CAPACITY

Farms participating in the Vietnam Food Safety Chain (VfSC) are taken soil and water samples and tested according to National Standard TCVN 11892-1:2017 on Good Agricultural Practices (VIETGAP). More than 100 farms have applied VfSC software in production and business. VfSC software applies Blockchain technology platform to production, location management, work monitoring via GPS. The software also develops an epidemic warning system, production support and periodic reminders. With farms applying VfSC software, all daily work will be recorded in the form of an electronic diary, transparent information throughout the production process. The highlight of Blockchain technology is that all information has been updated to the system cannot be edited or changed. All products and goods are input of VfSC chain shall be certified for conformity with standards and regulations by an independent certification organization and must ensure the unique access principle and able to access remotely to certification information and regulation conformity for each type of product.

PART 5. FACTORY CAPACITY, MACHINERY

On 10/10/2020, Vifotec launched preliminary processing and packing facility at 130 Nguyen Duc Canh Street, Tuong Mai Ward, Hoang Mai District, Hanoi

- Preliminary processing and packing with material receiving areas, Preliminary processing area, spacious and clean storage warehouse with modern equipment. Rinsing system with NaOCl solution with suitable concentration for each type of vegetable, tuber and fruit.
- Vifotec invests in cold supply chain from refrigerator truck to refrigerator storage to ensure the freshness of the product from harvest to the consumer: trucks transport raw materials from the farm to the processing facility and deliver the product to the consumer; Storage system includes refrigerated storage and frozen storage
- Vifotec has been granted code by the Plant Protection Department to pack fresh fruits and vegetables for export to the EU market.
- The company applies the Food Safety Management System according to ISO 22000:2018.
